**PIPE RELOCATION WORKS AT LEBUH SUNGAI PINANG:
 12-HOUR SCHEDULED WATER SUPPLY INTERRUPTION IN
 AREAS AT LEBUH SUNGAI PINANG ON 6.11.2020**

| Reason | Relocation of existing 600mm Mild Steel (MS) at Lebuhsungai Pinang away from a development site. |

PENANG, Friday (30.10.2020): There will be a 12-hour overnight scheduled water supply interruption at areas in Lebuhsungai Pinang from 9.00pm on Friday, 6.11.2020, to 9.00am on Saturday, 7.11.2020.

Perbadanan Bekalan Air Pulau Pinang will temporarily shut down an existing 600mm MS water supply pipeline to facilitate pipe relocation works from the junction at Lebuhraya Tun Dr. Lim Chong Eu to Lebuhsungai Pinang.

This pipeline shutdown will cause a 12-hour scheduled water supply interruption and will affect about 4,000 water accounts.

The pipeline relocation works are necessary to ensure that development activities at Lebuhsungai Pinang do not damage existing water pipes in the area.

Affected Consumers

Consumers in the following areas are requested to store sufficient water beforehand, for use from 9.00pm on Friday 6.11.2020 – 9.00am on Saturday 7.11.2020:
